Gender Violence: Trends and Issues

Abstract

Gender-based violence (GBV) continues to be a pervasive challenge in India, affecting the safety, health, and socio-economic empowerment of women. This paper analyses National Crime Records Bureau (NCRB) data from 1995 to 2021 across various categories of violence against women, identifies key trends, and explores the economic and social implications.

The study reveals a consistent rise in most categories of violence, persistent underreporting, and systemic challenges in enforcement. The findings underscore the need for integrated policy frameworks, enhanced legal enforcement, and gender-sensitive socio-economic planning.

Introduction

Gender violence, rooted in structural inequalities, remains a significant barrier to gender equality and national development. Gender violence, particularly against women and girls, has profound economic consequences, both at the individual and national levels. Gender-based violence in India is a serious and persistent issue, with widespread and deeply rooted societal, cultural, and institutional factors contributing to its prevalence. A 2019 NFHS-5 report revealed that 1 in 3 women (aged 18–49) had experienced physical or sexual violence. Gender-based violence (GBV) significantly undermines socio-economic development by impeding individual potential, straining public resources, and deepening systemic inequalities. Survivors of violence often withdraw from work due to trauma, stigma, or safety concerns.

Physical injuries, psychological stress, and absenteeism result in lower output at both individual and national levels. Studies (World Bank) estimate that violence against women can cost up to 1.5% of a country's GDP. Treating injuries, trauma, and chronic illnesses related to violence places a heavy burden on public health systems. Investigating and prosecuting gender violence cases consumes substantial legal resources. Support for displaced or abused women (shelters, rehabilitation, etc.) requires sustained government investment. The prevalence of gender-based violence (GBV) in India is both widespread and underreported, cutting across class, caste, region, and religion. It represents a major barrier to gender equality and sustainable development.

Gender-Based Violence (GBV) In India: Gender-based violence (GBV) in India is pervasive yet significantly underreported, affecting individuals across all social strata—irrespective of class, caste, region, or religion. It poses a critical obstacle to achieving gender equality and hampers the nation's progress toward inclusive and sustainable development. Total crimes against women: Over 428,278 cases reported. Cruelty by husband or in-laws (Section 498A IPC): ~137,956 cases — the most reported form of violence.

(Section 376 IPC): 31,677 cases — nearly 87 per day. Kidnapping and abduction of women: 71,000+ cases. Dowry deaths: 6,589 cases. Acid attacks: 176 reported cases. The following is a structured analysis of its prevalence within the Indian socio-economic landscape:

Demographic Indicators of Gender Bias: Despite a slight improvement in the overall sex ratio from 927 (1995) to 943 (2021), the child sex ratio declined from 927 (2005) to 919, reflecting ongoing female foeticide and son preference. Because of weak enforcement of prenatal laws, only 70 cases were filed under the PCPNDT Act in 2021, highlighting inadequate enforcement against sex-selective abortions.

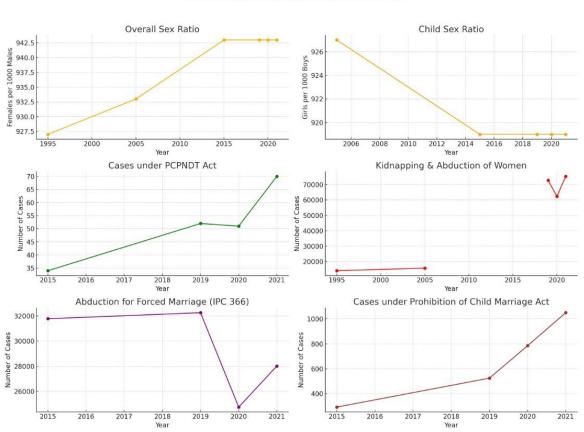
Patterns of Violence: Kidnapping and abduction of women rose fivefold, from 15,750 (2005) to 75,369 (2021). Many of these fall under Section 366 IPC (abduction for forced marriage), underscoring continued prevalence of forced marriages, compounded by weak enforcement of child marriage and trafficking laws.

Domestic Violence and Cruelty by Husbands/Relatives: Reported cases rose from 28,579 (1995) to 137,234 (2021), making this the largest category of crimes against women. However, just 507 cases were filed under dedicated domestic violence laws in 2021, indicating serious underreporting and limited trust in the justice system.

Honour Killings: Although only 33 cases were officially reported in 2021, anecdotal evidence suggests significant underreporting. Family complicity and societal pressure inhibit disclosure, making honour-based violence a silent yet dangerous form of GBV.

Dowry-Related Violence: With 6,753 dowry deaths in 2021 and rising cases under the Dowry Prohibition Act, dowry-related crimes remain a persistent problem. These reflect patriarchal norms and economic coercion in marriage practices.

Sexual Violence: Rape cases more than doubled from 13,754 (1995) to 31,677 (2021). Most offenders are known to the victim, highlighting the embedded nature of sexual violence within families and communities. Other forms include incest, custodial rapes, and rape-murders.



Trends in Gender-Based Violence Indicators in India

Emerging and Underreported Forms of Violence: Violence against women has also shown changing patterns in recent times, also, very few of the violence against women get reported because of different reasons.

- i. **Public and Workplace Harassment:** "Outraging modesty" cases increased from 4,689 (1995) to 7,788 (2021). Only 418 workplace harassment cases were reported in 2021, likely due to fear of reprisal and poor implementation of the POSH Act (2013). Stalking and voyeurism have also sharply increased.
- ii. **Acid Attacks:** Though limited in number (102 cases in 2021), acid attacks cause irreversible disfigurement and trauma, often pushing victims to the economic and social margins of society.
- iii. **Trafficking and Exploitation:** While cases under the Immoral Traffic Prevention Act have declined, other forms of trafficking and procuration remain widespread. The apparent drop likely reflects underreporting and evolution of trafficking methods rather than actual progress.
- iv. **Cyber Crimes Against Women:** Cyber crimes targeting women rose from 8,379 (2019) to 10,730 (2021), including cyberstalking, blackmail, and distribution of explicit content. Poor enforcement and digital illiteracy compound women's vulnerability online.
- v. **Violence Against Marginalized Groups:** Rape and abduction cases involving Scheduled Caste (SC) and Scheduled Tribe (ST) women have increased significantly. In 2021, 3,870 SC women were raped, compared to 2,326 in 2015, revealing the intersectionality of caste and gender-based violence.
- vi. **Indecent Representation of Women:** Cases under the Indecent Representation of Women Act fell from 2,917 (2005) to 28 (2021). This drop likely reflects a combination of legal inattention, shifts to digital platforms, and underreporting rather than actual improvement.

Socio-Economic Impacts of Gender-Based Violence

- i. **Loss of Productivity:** Victims often suffer long-term physical and mental health issues, leading to absenteeism or underperformance (presenteeism). Businesses also incur higher costs due to reduced employee morale and increased turnover.
- ii. **Increased Healthcare Expenditures:** Treatment of physical injuries and mental trauma imposes high costs on both families and public health systems, diverting resources from education and development.
- **Erosion of Human Capital:** Violence disrupts education, especially for girls facing abuse or early marriage, leading to school dropouts and reduced lifetime earnings, limiting long-term human capital formation.
- **iv. Intergenerational Poverty and Trauma:** Children in violent households often face developmental delays, lower academic performance, and higher risk of becoming future perpetrators or victims, perpetuating cycles of poverty and inequality.
- v. Pressure on Social Protection and Justice Systems: Rising violence necessitates more spending on policing, legal proceedings, rehabilitation, and shelters, creating budgetary strain and reducing investment in other development areas.

Negative Impact on Economic Growth: According to the World Bank, intimate partner violence can cost 1.2% to 3.7% of a country's GDP. GBV weakens labor supply, deters innovation, and stalls inclusive development.

- i. Labor Market Gender Inequality: Gender violence discourages women's workforce participation and upward mobility, reinforcing gender wage gaps and limiting access to leadership roles.
- ii. Decline in Investment and Tourism: Countries with high GBV levels may be seen as unsafe or unstable, discouraging foreign direct investment (FDI) and reducing tourism revenues.

Policy Recommendations:

- Strengthen enforcement of laws like the PCPNDT, Dowry Prohibition, POSH, and Domestic Violence Acts.
- Enhance gender-sensitization training for police, judiciary, and public servants.
- Improve victim reporting and support systems, including helplines, shelters, and legal aid.
- Integrate gender equality into development policies across education, employment, health, and digital inclusion sectors.
- Promote community-led awareness campaigns to challenge patriarchal norms and foster safe spaces for women and girls.
