School of social work is a specialized field of social work that trained the social worker for addressing the emotional, behavioral and social challenges faced by students in school or any educational settings. It provides opportunities for trained social worker to support education system in addressing various challenges and creating an effective learning environment.

The National Association of Social Work (NASW)emphasizes the need for establishing Schools of Social Work in alignment with the NEP-2020. NEP-2020 focuses on enhancing education quality and ensuring inclusive access, the association advocates for trainedsocial work professional to support students, teachers, and communities effectively. Schools of Social Work can play a critical role in addressing learning barriers, promoting mental well-being, teacher-parent collaboration, ensuring inclusion & equity and foster community participation, aligning with the NEP-2020's vision for holistic, inclusive and effective learning development and equitable education.

In 2005, National Association of Professional Social Workers in India (NPASWI) was established to strengthen social work profession all over the country. It contributed in various ways to improve the quality of services for social welfare and development. In the year 2019, it started a campaign to establish school complexes and appoint school social workers to help the teachers as well as students and make the learning process easier.

School of Social Work Association of America (SSWAA) also defines School of Social Work as a specialized field within the broader social work profession, focusing on supporting students' well-being and academic success. School social workers bring unique expertise to the educational system and student services teams. As trained mental health professionals, they address mental health and behavioral concerns; provide positive behavioral support, and offer academic and classroom assistance. They also collaborate with teachers, parents, and administrators while delivering individual and group counseling or therapy. By promoting a conducive environment for teaching, learning, and personal growth, school social workers play a vital role in advancing

UNESCO highlighted the need for the awareness of inclusive education in the Sustainble development goal-4: ensuring inclusive, equitable and quality education and the promotion of lifelong learning opportunities for all.

Social workers can help identify and address barriers to ensure that all students have equal educational opportunities. They have significant role in supporting to students from marginalized section such as children with special needs and mainstream them towards barrier free education for all.

• School -family interaction

School is a place where children learn, grow and acquire skills. School of social work advocates for strong partnerships between schools and families through parent education programs and home visits. Students often carry burden of family problems in schools, Social workerworkas a connecting link to build a strong bond between student, parents and teachers. Through this partnership social worker contributes to early identification and intervention of student's behavioral problems and improves student's mental health. Students with a better adjustment with him, school and parents achieve improved academic success.

• Counseling services-

• Community collaboration

Social workers can help foster collaboration between schools, family, community and local organizations. It provides opportunities for students to understand social needs and problems.
